The Board does not take formal action on the items.

#### **TRUSTEE COMMENTS**

In addition, the Board may provide a referral to staff or other resources for factual information, request staff to report back to the body at a subsequent meeting concerning any Library matter, or direct staff to place a request to agendize a matter of business on a future agenda.
