RESOLUTION MAKING CERTAIN FINDINGS AND DETERMINATIONS IN COMPLIANCE WITH SECTION XIII B OF THE CALIFORNIA CONSTITUTION (GANN INITIATIVE)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MONTEREY that in compliance with section XIII B of the Constitution of the State of California, the following is hereby found and determined:

1. That the appropriation subject to limitation for the current fiscal year 2003-04 was found to be \$68,340,639;
2. That during the fiscal year 2003-04 the California per capita income increased 3.28%, and the population of the County of Monterey increased 1.56%;
3. That the appropriations subject to limitation for fiscal year 2004-05 is \$71,682,496.


