

RESOLUTION NO. 06 - 86

**RESOLUTION AMENDING CHARGES AND FINES
FOR THE PUBLIC FACILITIES DEPARTMENT**

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MONTEREY that the following fines and charges for the Parking Division be amended as follows:

Effective January 1, 2007, the fine for a parking citation issued for overtime and expired meter shall be \$25.00. The fine for a parking citation issued for blocking a fire hydrant shall be \$50.00.

Effective July 1, 2006, the fee to reserve an on-street parking space shall be increased to \$10.00 per space for general use and \$45.00 per space for display. In addition the City Manager, or his designated representative, is authorized to negotiate and set fees to reserve parking spaces for special events or functions.

BE IT FURTHER RESOLVED that all revenue received is deposited into the Parking Fund, which supports all Parking operations. These fines and charges, along with the established charges for other Parking programs, do not exceed the cost of providing services and facilities.

BE IT FURTHER RESOLVED that the charges for the following services provided by the Harbor/Marina Division are amended effective July 1, 2006 as follows:


| <u>SERVICE</u> | <u>CHARGE</u> |
|--------------------------------------|----------------------|
| Crane | \$200.00 per hour |
| Towing | \$100.00 per hour |
| Water removal | \$ 45.00 per hour |
| Yellow Boat Dock (Dive Boat Loading) | \$150.00 per month |
| Boat rack (Dry Storage) | \$ 54.00 per quarter |
| Kayak rack (Dry Storage) | \$ 36.00 per quarter |
| Dinghy Space (Marina) | \$ 90.00 per quarter |
| Dinghy Space (Wharf 1) | \$ 54.00 per quarter |

BE IT FURTHER RESOLVED that all revenue received from these charges is deposited into the appropriate Marina Fund or General Fund account, which supports all Marina and Harbor activities. These charges, along with the established charges for activities in the Marina and Harbor, do not exceed the cost of providing Harbor/Marina services and facilities.


