My name is Hal McKay. My wife, Esther and I have lived at 5 Toda Vista for 33 years. I am retired from the Monterey Fire Department after 25 yrs. I am about $90 \%$ disabled from my injuries on the job. I have a constant pain level of an 8 on a 0-10 scale. I have two spinal cord stimulators that cover both of my arms from my shoulder to my fingertips. The other stimulator covers both of my legs from my hips to my toes. I cannot have an MRI because they are not compatible with my stimulator. Putting this cell tower so close to our 2 story bedroom , windows will make it so I will never be able to use my stimulator which will increase my pain level to a 10 out of 10 and reduce my sleep to 0 . I hope the subcommittee will consider tight restrictions within the residential neighborhoods, to include no closer than 500 feet to a home and 1500 feet between poles as Petaluma, CA is.

With this device in front of our house my wife and I will have to move. Who is willing to compensate us the $20 \%$ devaluation of our home because of the cell towers? Is the city, ExteNet, or Verizon going to? My wife and I love this area and carefully picked out the location of our home. We have supported this city for a long time. Now that we are both retired we live on a fixed income. Having to move and start all over again is an option that is not available to us. We should not have to uproot our lives and have me live in constant pain so a company can make more money. This is something no one should have to do.

Technology should never be at the risk of endangering the citizens; animals and the environment. Utilities should be placed underground.
